CONFLICT OF INTEREST STATEMENT

Authors are responsible for disclosing all financial and personal relationships that might bias their work. Financial relationships (such as employment, consultancies, stock ownership, honoraria, paid expert testimony) are the most easily identifiable conflicts of interest and the most likely to undermine the credibility of the journal.

To prevent ambiguity, authors must state explicitly in the letter accompanying the submitted manuscript whether potential conflicts do or do not exist.

Authors are required to include the following above the Abstract.

“Conflict of interest

The author/s of this paper declare/s no conflict of interest.”

Disclaimer

Facts and opinions published in the Journal of Health, Safety and Environment express solely the opinions of the respective authors. Authors are responsible for their citing of sources and the accuracy of their references and bibliographies. The editors cannot be held responsible for any lacks or possible violations of third parties’ rights.

Statement of informed consent

All descriptive or analytical investigations on human participants must include a statement in the Methods section that participants gave their informed consent. The name of the relevant institutional ethics approval committee that gave approval for the study and the appropriate approval number must be stated in the Methods section. It is journal policy that participant anonymity must be preserved in all cases.

Manuscripts based on studies involving Aboriginal or Torres Strait Islander participants must also state that the relevant local Indigenous representatives have approved the study.

Protection of human and animal rights

Where applicable, authors should provide assurance that they are aware of all applicable ethical safeguards with regard to human and animal rights and that, through compliance with appropriate ethics legislation, systems and processes, they have complied with such safeguards.

Research involving human subjects

The Journal will consider manuscripts presenting data obtained from research involving human subjects. Research on human subjects must:

- (1) be approved by an appropriate institutional ethics approval committee; that is:
 - (a) (within Australia) the research was conducted according to the principles of the most recent edition of the NHMRC *National Statement on Ethical Conduct in Human Research* (<http://www.nhmrc.gov.au>); or
 - (b) (outside Australia) the research was conducted following appropriate human ethics approval processes, including compliance with the World Medical Association *Declaration of Helsinki* (<http://www.wma.net>) and
- (2) comply with all applicable legislation and procedures.

A statement describing institutional ethics approval and consent procedures, and indicating that all human participants gave written informed consent, must appear within the Methods section of the manuscript.

In addition, authors will be asked to indicate and certify in the letter that accompanies the manuscript at the time of submission a statement that:

- (1) they have complied with all applicable legislation and procedures relating to human ethics approvals; and
- (2) they confirm their understanding that the editor may request to see any or all documentation relating to this statement.

Research involving experimental animals

The Journal will consider manuscripts presenting data obtained from research involving experimental animals (including survey work). Research on experimental animals must:

- (1) be approved by an appropriate institutional ethics approval committee; that is:
 - (a) (within Australia) the research was conducted according to the principles of the latest edition of the NHMRC *Australian Code of Practice for the Care and Use of Animals for Scientific Purposes* (<https://www.nhmrc.gov.au>); or
 - (b) (outside Australia) the research was conducted according to the principles of a national equivalent to the Australian code of practice; and
- (2) comply with all applicable legislation and procedures.

A statement describing institutional ethics approval, and indicating that animal handling procedures comply with such approvals, must appear within the Methods section of the manuscript.

In addition, authors will be asked to indicate and certify in the letter that accompanies the manuscript at the time of submission a statement that:

- (1) they have complied with all applicable legislation and procedures relating to experimental animal ethics approvals; and
- (2) they confirm their understanding that the editor may request to see any or all documentation relating to this statement.

Funding

Authors must include a statement at the conclusion of the paper that identifies any funding sources for their work. This will be removed for anonymous peer review but re-inserted for publication.

Risk assessment

Authors must include a statement in the Methods section of compliance to any risk assessment procedures required by their organisations.

Peer-review process

All feature articles, research reports and editorials are submitted for expert peer-review. In the case of feature articles, authors and referees remain anonymous. In other forms of submission a review is conducted with author identity disclosure. Refer to “Instructions to authors”.

A reviewer may make suggestions as to acceptance, revision or rejection of manuscripts.

In certain cases, specialist peer reviewers (such as statisticians) will be used, for example, for review of study design features, conduct of the study, presentation of data, statistical analysis, or conclusions.

If the reviewers indicate that a manuscript should be revised, authors will be requested to revise the manuscript along the lines indicated by the referees.

Occasionally, resubmitted manuscripts may undergo further peer review. Once revisions are completed and approved by the Managing Editor, the corresponding author is notified that an article has been accepted for publication.

Rejected manuscripts will not be returned to authors.

Copyright

Articles with original material are accepted for consideration with the understanding that, except for abstracts, no part of the data has been published, or will be submitted for publication elsewhere, before appearing in this Journal. Authors are required to assign copyright to CCH Australia Limited when their article is accepted for publication. The copyright assignment letter must be signed by all authors and a copy returned to the Managing Editor. Assignment of copyright protects the interests of both author and publisher.

Copyright in all material submitted for publication in the Journal has to vest in CCH Australia Limited. Although publication elsewhere is prohibited by such assignment of copyright, the material may be used by the author(s):

- ◆ for academic purposes (such as lecturing);
- ◆ for private use (excluding sale for profit);
- ◆ for teaching purposes;
- ◆ for professional advice to clients; and
- ◆ as part of non-commercial instructional publications.

Authors are required to warrant that the submitted material does not (or will not), to the best of their knowledge, infringe any copyright or other proprietary right or interest, or contain any statement which is false, libellous, or in any other way unlawful. Permission must be gained to reproduce any figure, table or extensive extract (over 50 words) from any source that is owned or copyrighted by anyone other than the author or CCH Australia Limited.
